DIRECTORS' REPORT

The directors present this report on the consolidated entity consisting of Gay and Lesbian Foundation of Australia Ltd and the entities it controlled during the financial year ended 30 June 2015. Throughout the report, the consolidated entity is referred to as the group. The controlled entities during the year comprise the GALFA Public Fund (ABN 82 567 458 934) and GALFA Charitable Fund (ABN 45 880 774 771), for which the company acts as Trustee.

Directors

The names of each person who has been a director during the year and to the date of this report are:

All the above directors have been in office since the start of the financial year to the date of this report, except Ms. Carol Wilkinson who resigned during the year.

Company Secretary

The following person held the position of secretary since the start of the financial year to the date of this report:

Ms. Sarina Jackson – Solicitor, partner of Douros Lawyers, has been a legal practitioner for 16 years, admitted to practice in New South Wales and Victoria. Sarina practices in the areas of commercial law, banking and finance, insolvency and litigation.

Principal Activities

The principal activities of the group during the financial year were: publicising the foundation; raising funds from donations and bequests; calling for and assessing grant applications; making grants to successful applicants; and, facilitating other philanthropic and charitable organisations to co-invest in projects supported by GALFA. No significant change in the nature of the group's activities occurred during the financial year.

Operating Results

The operating profit of the group amounted to \$31,320 (2014: \$11,458), after grants totalling \$10,000 (2014 \$1,000 - Lesbian Parenting Aust Inc.) which were awarded as follows:-

Helping Hand Aged Care Inc. - \$5,000

The 'Turn Up Your Voice' project grant was made to Helping Hand Aged Care Inc. in South Australia. The project will develop a model practice of aged care that is inclusive of older LGBTI people and their carers so that they provide meaningful input into aged care service planning, delivery and evaluation and in doing so overcome the past 'invisibility' of LGBTI people in aged care. The project will provide a national example for other aged care organisations on inclusion of LGBTI people and their carers. This is a joint funded grant, in

collaboration with the Sidney Myer Fund who contribute a further \$10,000.

The grant was made subject to usual conditions, including:

- the funds are used exclusively for the purpose as set out in the application for the grant,
- best endeavours are to be made to complete the project within 12 months,
- separate management accounts are to be maintained in respect of the grant, which are to be available on request, and,
- an acquittal report will be provided within 15 months of the grant.

National LGBTI Health Alliance - \$5,000

This is a jointly funded grant, in association with the Sidney Myer Fund (contributing \$10,000), towards the Virtual Visitors project initiated by National LGBTI Health Alliance. The Virtual Visitor project will test the feasibility of a wide scale online visitor scheme with LGBTI elders who are socially isolated and/or living alone, using LGBTI peers as visitors. The project is volunteer and peer (LGBTI) based and will offer online, skype and social media contact with volunteers. This can either be one to one, in hubs or in groups. Older LGBTI people will be identified and encouraged to join the program, as recipients and volunteers, where they can share life stories and experiences. The outcome is to decrease isolation and build networks of support.

The grant was made subject to usual conditions, including:

- the funds are used exclusively for the purpose as set out in the application for the grant,
- best endeavours are to be made to complete the project within 12 months,
- separate management accounts are to be maintained in respect of the grant, which are to be available on request, and,
- an acquittal report will be provided within 15 months of the grant.

This year the group has received significant donations from Broadtree Foundation (\$20,000) and Hanover Welfare (\$10,000) which were made with certain conditions. Memoranda of Understanding were co-signed by the donors and GALFA.

Broadtree Foundation:

This money is to be set aside for the purposes of funding a project that is mutually agreed upon by both parties, and applied to the area of disability amongst lesbian, bisexual, gay, transgender and/or intersex (LGBTI) people in Australia. Details of the project brief or project parameters will be decided and money allocated during the 2015/2016 financial year. If suitable applicants are not forthcoming, the grant will be potentially broadened in scope and re-advertised. Representatives from Broadtree Foundation will be members of the project advisory committee.

Hanover Welfare Services:

This money is a contribution to the LGBT Homelessness Project that will conduct a prevalence and needs assessment LGBT homelessness. It is conditional on the project proceeding before 18 June 2016. Should the project not proceed within this time, the \$10,000 should be returned to Hanover/Launch Housing, unless otherwise agreed by Hanover/Launch Housing. Representatives from Hanover have been members of the project advisory committee since its inception and the funding contribution was made on the basis of the project as described in the advisory committees written project brief.

Dividends Paid or Recommended

Item 5 of the Constitution states that company property and income must be applied solely towards promoting the company's objective, and that no distribution may be made to Members. Therefore no dividends were paid or declared since the start of the financial year and a recommendation for payment of a dividend cannot be made.

Review of Operations

The results of the operations of the group during the financial year reflect ongoing fundraising and grant making activities.

Significant Changes in State of Affairs

No significant changes in the group's state of affairs occurred during the financial year, although the group has developed its charitable and grant giving capacity to attract donations, and has obtained co-funding from other philanthropic organisations so as to offer grants to organisations that meet approved criteria.

After Balance Date Events

No matters or circumstances have arisen since the end of the financial year, which significantly affected or may significantly affect the operations of the group, the results of those operations, or the state of affairs of the group in future financial years.

Future Developments

The Board has plans to further develop the charitable and grant giving capacity and to attract donations, seek further co-funding from other philanthropic organisations and offer grants to organisations that meet approved criteria. Where volunteer resources allow, GALFA will assist GLBTI organisations access mainstream philanthropy.

Environmental Issues

The group's operations are not regulated by any significant environmental regulation under a law of the Commonwealth or of a state or territory.

1. STATEMENT OF SIGNIFICANT ACCOUNTING POLICIES

The directors have prepared the financial statements on the basis that the company is a non-reporting entity because there are no users who are dependent on its general-purpose financial reports. This financial report is therefore a special purpose financial report that has been prepared in order to meet the requirements of the Corporations Act 2001.

The consolidated financial report is for Gay and Lesbian Foundation of Australia Ltd (a company limited by guarantee), incorporated and domiciled in Australia, and the entities it controlled during the financial year ended 30 June 2015. Throughout the report the consolidated entity is referred to as the group. The controlled entities during the year comprise the GALFA Public Fund (ABN: 82 567 458 934) and GALFA Charitable Fund (ABN: 45 880 774 771), for which the company acts as Trustee.

Basis of Preparation

The report has been prepared in accordance with the requirements of the Corporations Act 2001, and the following applicable Australian Accounting Standards and Australian Accounting Interpretations.

AASB 10:	Consolidated Financial Statements;
AASB 101:	Presentation of Financial Statements;
AASB 107:	Cash Flow Statements;
AASB 108:	Accounting Policies, Changes in Accounting Estimates and Errors;

No other Accounting Standards, Accounting Interpretations or other authoritative pronouncements of the Australian Accounting Standards Board have been applied.

Reporting Basis and Conversions

The financial statements have been prepared on an accruals basis and are based on historical costs unless otherwise stated in the notes. It does not take into account changing money values or, except where stated, current valuations of non-current assets. Cost is based on the fair values of the consideration given in exchange for assets.

1. STATEMENT OF SIGNIFICANT ACCOUNTING POLICIES (cont)

The following is a summary of the material accounting policies adopted by the group in the preparation of the financial report. The accounting policies have been consistently applied, unless otherwise stated.

Accounting Policies

a. Revenue

- (i) Donations and grants received are recognised as revenue when received unless they are for a specific purpose, where they are carried forward as prepaid income on the balance sheet.
- (ii) Interest revenue is recognised using the effective interest rate method, which, for floating rate financial assets is the rate inherent in the instrument.

b. Financial Instruments

Recognition and Initial Measurement

Financial instruments, incorporating financial assets and financial liabilities, are recognised when the entity becomes a party to the contractual provisions of the instrument.

Trade date accounting is adopted for financial assets that are delivered within timeframes established by marketplace convention.

Financial instruments are initially measured at fair value plus transactions costs where the instrument is not classified at fair value through profit or loss. Transaction costs related to instruments classified as at fair value through profit or loss are expensed to profit or loss immediately. Financial instruments are classified and measured as set out below.

Derecognition

Financial assets are derecognised where the contractual rights to receipt of cash flows expires or the asset is transferred to another party whereby the entity no longer has any significant continuing involvement in the risks and benefits associated with the asset. Financial liabilities are derecognised where the related obligations are either discharged, cancelled or expire. The difference between the carrying value of the financial liability extinguished or transferred to another party and the fair value of consideration paid, including the transfer of non-cash assets or liabilities assumed is recognised in profit or loss.

b. Financial Instruments (cont)

Classification and Subsequent Measurement

(i) Financial assets at fair value through profit or loss

Financial assets are classified at fair value through profit or loss when they are held for trading for the purpose of short term profit taking, where they are derivatives not held for hedging purposes, or designated as such to avoid an accounting mismatch or to enable performance evaluation where a group of financial assets is managed by key management personnel on a fair value basis in accordance with a documented risk management or investment strategy. Realised and unrealised gains and losses arising from changes in fair value are included in profit or loss in the period in which they arise.

(ii) Loans and receivables

Loans and receivables are non-derivative financial assets with fixed or determinable payments that are not quoted in an active market and are subsequently measured at amortised cost using the effective interest rate method.

(iii) Held-to-maturity investments

Held-to-maturity investments are non-derivative financial assets that have fixed maturities and fixed or determinable payments, and it is the company's intention to hold these investments to maturity. They are subsequently measured at amortised cost using the effective interest rate method.

(iv) Available-for-sale financial assets

Available-for-sale financial assets are non-derivative financial assets that are either designated as such or that are not classified in any of the other categories. They comprise investments in the equity of other entities where there is neither a fixed maturity nor fixed or determinable payments.

(v) Financial liabilities

Non-derivative financial liabilities (excluding financial guarantees) are subsequently measured at amortised cost using the effective interest rate method.

Fair value

Fair value is determined based on current bid prices for all quoted investments. Valuation techniques are applied to determine the fair value for all unlisted securities, including recent arm's length transactions, reference to similar instruments and option pricing.

Impairment

At each reporting date, the entity assesses whether there is objective evidence that a financial instrument has been impaired. In the case of available-for-sale financial instruments, a prolonged decline in the value of the instrument is considered to determine whether impairment has arisen. Impairment losses are recognised in the Income Statement.

c. Impairment of Assets

At each reporting date, the group reviews the carrying values of its tangible and intangible assets to determine whether there is any indication that those assets have been impaired. If such an indication exists, the recoverable amount of the asset, being the higher of the asset's fair value less cost to sell and value in use, is compared to the asset's carrying value. Any excess of the asset's carrying value over its recoverable amount is expensed to the Income Statement.

Where the future economic benefits of the asset are not primarily dependent upon on the assets ability to generate net cash inflows and when the entity would, if deprived of the asset, replace its remaining future economic benefits, value in use is depreciated replacement cost of an asset.

Where it is not possible to estimate the recoverable amount of a class of asset, the entity estimates the recoverable amount of the cash-generating unit to which the asset belongs.

d. Cash and cash equivalents

Cash and cash equivalents include cash on hand, deposits held at-call with banks, other short-term highly liquid investments with original maturities of three months or less, and bank overdrafts.

e. Goods and Services Tax (GST)

Revenues, expenses and assets are recognised inclusive of the amount of GST, as GST incurred is not currently recoverable from the Australian Taxation Office. In these circumstances the GST is recognised as part of the cost of acquisition of the asset or as part of an item of expense. Receivables and payables in the Balance Sheet are shown inclusive of GST.

Cash flows are presented in the Cash Flow Statement on a gross basis, except for the GST component of investing and financing activities, which are disclosed as operating cash flows.

f. Income Tax Expenses

No provision for income tax has been raised, as the entity is exempt from income tax under Division 50 of the Income Tax Assessment Act 1997.

g. Provisions

Provisions are recognised when the group has a legal or constructive obligation, as a result of past events, for which it is probable that an outflow of economic benefits will result and that outflow can be reliably measured.

h. Comparative Figures

Where required by Accounting Standards comparative figures have been adjusted to conform with changes in presentation for the current financial year.

i. Critical Accounting Estimates and Judgments

The directors evaluate estimates and judgments incorporated into the financial report based on historical knowledge and best available current information. Estimates assume a reasonable expectation of future events and are based on current trends and economic data, obtained both externally and within the entity.
