The principal activities of the entity during the financial year were the establishing the foundation and applying for Tax Deductible Status which has now been achieved. No significant change in the nature of the entity's activities occurred during the financial year.

The operating profit of the entity amounted to \$189 (2007 operating loss: \$148).

No dividends were paid or declared since the start of the financial year. No recommendation for payment of dividends has been made.

The results of the operations of the entity during the financial year reflect decisions taken by Directors to establish the Foundation and apply for Deductible Gift Recipient status under the Income Tax Assessment Act 1997 as amended.

- Qualifications - Chartered Accountant, 20 years in private investment and general management. Since the mid 1990's Mark has volunteered for a number of UK and Australian GLBTI organisations including Lesbian and Gay Switchboard, the Albert Kennedy Trust (for homeless gay teens), and JOY 94.9.
- Mr Rodney Croome - Director
- Qualifications - as a spokesperson for the Tasmanian Gay and Lesbian Rights Group he fronted the successful campaign to decriminalise homosexuality in Tasmania. He has also been the project officer of the Human Rights and Equal Opportunity Commission's rural LGBT youth network, Outlink, and Co-convenor of the Australia Council for Lesbian and Gay Rights. In this latter capacity in 1993 Rodney became the first gay advocate to speak at a United Nations forum. Currently Rodney is a member of Tasmania's five LGBT community / government liaison committees, a Board Member of the International Lesbian and Gay Law Association, the Australian Coalition for Equality, Australian Marriage Equality and the Tasmanian LGBT support organisation, Working It Out. In recognition of his work Rodney was the recipient of the Tasmanian Humanitarian of the Year Award in 1991, and the national Chris Carter Memorial Award for contributions to the gay and lesbian community in 1991; he received the Tasmania Day Community Service Award 2000, was awarded a Centenary of Federation Medal in 2003 and made a Member of the Order of Australia in 2003

- Qualifications - Solicitor and partner of a law firm and based in Sydney and Melbourne. When living in Melbourne, she was on various boards of the ALSO Foundation including a time as President. She has been involved with Joy 94.9, HIV/AIDS Legal Centre and Victorian AIDS Council.

- Mr Colin Krycer - Director
- Qualifications - a committed volunteer in the HIV/AIDS field and the general Gay and Lesbian community for the past twenty years. Colin has been successful in fundraising and served on numerous committees. He is one of the earliest members of JOY 94.9.
- Dr Ruth McNair - Director
- Qualifications - A general practitioner specialising in lesbian health and women's health. She is also a Senior Lecturer at the Department of General Practice, University of Melbourne. She is a member of the Victorian Ministerial Advisory Committee on GLBTI health and wellbeing, and was on Victorian Attorney General's Advisory Committee on Gay and Lesbian Issues from 2001 to 2006. She was the founding Convener of the Fertility Access Rights Lobby from 1999 to 2004 and was Convener of the Australian Lesbian Medical Association from 2002 to 2005. She is the inaugural treasurer of the Rainbow Families Council. In 2006 she received the Quiet Achiever Rainbow Award, and in 2007 she was made a life member of the Victorian Gay and Lesbian Rights lobby.
- Mr Bruce McNicol - Director
- Qualifications - Bruce McNicol was a visionary whose inspiration led to the establishment of GALFA. He was a counselling and industrial psychologist, entrepreneur, investor, and ran Human Learning Pty Ltd, an Australian wide registered private training provider. He made a huge contribution to gay and lesbian life in Melbourne. In 1979, he helped organise Melbourne's first big gay event "The 5th National Homosexual Conference". In 1982 he worked with ALSO as a psychologist and in 1983 was instrumental in establishing the Victorian AIDS Council (VAC). He continued as a gay affirmative counsellor and educator and set up the carer's training program (AIDS MATES) with VAC and Fairfield House. He served as a board member of the ALSO Foundation for ten years, and was co-chair of the ALSO Community Development and Services Program. He started and published the "G'Day accommodation and travel guides", and was a part owner of Turtle Cove, a world recognised exclusively Lesbian and Gay resort. He was secretary of AGALTA (the Gay Tourism Association) for 3 years and was a founder of Rainbow Travel. He supported the costume ball, The Fantasy Ball for more than 6 years. In his multicultural work he was the patron of the Miss Gay Asia Pacific Quest and the Australian Representative of the LGHEI, Lesbian and Gay Hospitality Exchange International. He was the founder of GLADE (Gay and Lesbian Assoc for Developing Enterprise) and one of the initiators of Melbourne's unique Rainbow Awards. He also offered advice and support to set up Melbourne's gay and lesbian radio station JOY 94.9. He continued his volunteer work on a worldwide basis by working as a director of the International Lesbian and Gay Association (ILGA). Its mission was to work globally for the equality of lesbian, gay, bisexual and transgender people.

- Qualifications – CEO of VCOSS (Victorian Council of Social Service) responsible for active policy work in the areas of children, young people and families, disability, education and training, emergency relief, energy and water, health, housing, human rights, justice, transport, community-government partnerships, welfare reform and other issues of social and economic disadvantage. She spent most of the 1990s working in international development; playing various senior roles in advocacy, operations, marketing and communications management at Community Aid Abroad (now Oxfam Australia). Prior to that, from 1985 to 1991, she worked in policy, fundraising and campaigning roles for the environment movement.

1. STATEMENT OF SIGNIFICANT ACCOUNTING POLICIES

The financial report is a special purpose financial report that has been prepared in accordance with the Corporations Act 2001.

The financial report is for Gay and Lesbian Foundation of Australia (a company limited by guarantee) as an individual entity, incorporated and domiciled in Australia.

Basis of Preparation

The report has been prepared in accordance with the requirements of the Corporations Act 2001, and the following applicable Australian Accounting Standards and Australian Accounting Interpretations.

AASB 101: Presentation of Financial Statements;
AASB 107: Cash Flow Statements;
AASB 108: Accounting Policies, Changes in Accounting Estimates and Errors;
AASB 110: Events after the Balance Sheet Date;
AASB 1031: Materiality; and
AASB 1048: Interpretation and Application of Standards.

No other Accounting Standards, Accounting Interpretations or other authoritative pronouncements of the Australian Accounting Standards Board have been applied.

Reporting Basis and Conversions

The financial report has been prepared on an accruals basis and is based on historical costs. It does not take into account changing money values or, except where stated, current valuations of non current assets. Cost is based on the fair values of the consideration given in exchange for assets.

The following is a summary of the material accounting policies adopted by the entity in the preparation of the financial report. The accounting policies have been consistently applied, unless otherwise stated.

Accounting Policies

a. Revenue

- (i) Donations and grants received are recognised as revenue when received unless they are for a specific purpose, where they are carried forward as prepaid income on the balance sheet.
- (ii) Interest revenue is recognised using the effective interest rate method, which, for floating rate financial assets is the rate inherent in the instrument.

All revenue is stated net of the amount of goods and services tax (GST).

b. Property, Plant and Equipment

Each class of property, plant and equipment is carried at cost or fair values as indicated, less, where applicable, accumulated depreciation and impairment losses.

Property

Freehold land and buildings are measured on the cost basis less depreciation and impairment losses.

Increases in the carrying amount arising on revaluation of land and buildings are credited to a revaluation reserve in equity. Decreases that offset previous increases of the same class of asset are charged against fair value reserves directly in equity; all other decreases are charged to the income statement. Each year the difference between depreciation based on the revalued carrying amount of the asset charged to the income statement and depreciation based on the asset's original cost is transferred from the revaluation reserve to retained earnings.

Any accumulated depreciation at the date of revaluation is eliminated against the gross carrying amount of the asset and the net amount is restated to the revalued amount of the asset.

Plant and Equipment

Plant and equipment are measured on the cost basis less depreciation and impairment losses.

The carrying amount of plant and equipment is reviewed annually by directors to ensure it is not in excess of the recoverable amount from these assets. The recoverable amount is assessed on the basis of the expected net cash flows that will be received from the assets employment and subsequent disposal. The expected net cash flows have been discounted to their present values in determining recoverable amounts.

Depreciation

The depreciable amount of all fixed assets including buildings and capitalised leased assets, but excluding freehold land, is depreciated on a straight line basis over the asset's useful life to the economic entity commencing from the time the asset is held ready for use.

b. Property, Plant and Equipment (cont'd)

The depreciation rates used for each class of depreciable assets are:

Class of Fixed Asset	Depreciation Rate
Building	2% to 12%
Plant and equipment	12% to 25%
Furniture and Fittings	9%

The assets' residual values and useful lives are reviewed, and adjusted if appropriate, at each balance sheet date.

An asset's carrying amount is written down immediately to its recoverable amount if the asset's carrying amount is greater than its estimated recoverable amount.

Gains and losses on disposals are determined by comparing proceeds with the carrying amount. These gains or losses are included in the income statement. When revalued assets are sold, amounts included in the revaluation reserve relating to that asset are transferred to retained earnings.

c. Financial Instruments

Recognition and Initial Measurement

Financial instruments, incorporating financial assets and financial liabilities, are recognised when the entity becomes a party to the contractual provisions of the instrument.

Trade date accounting is adopted for financial assets that are delivered within timeframes established by marketplace convention.

Financial instruments are initially measured at fair value plus transactions costs where the instrument is not classified at fair value through profit or loss. Transaction costs related to instruments classified as at fair value through profit or loss are expensed to profit or loss immediately. Financial instruments are classified and measured as set out below.

c. Financial Instruments (cont'd)

Derecognition

Financial assets are derecognised where the contractual rights to receipt of cash flows expires or the asset is transferred to another party whereby the entity no longer has any significant continuing involvement in the risks and benefits associated with the asset. Financial liabilities are derecognised where the related obligations are either discharged, cancelled or expire. The difference between the carrying value of the financial liability extinguished or transferred to another party and the fair value of consideration paid, including the transfer of non-cash assets or liabilities assumed is recognised in profit or loss.

Classification and Subsequent Measurement

(i) Financial assets at fair value through profit or loss

Financial assets are classified at fair value through profit or loss when they are held for trading for the purpose of short term profit taking, where they are derivatives not held for hedging purposes, or designated as such to avoid an accounting mismatch or to enable performance evaluation where a group of financial assets is managed by key management personnel on a fair value basis in accordance with a documented risk management or investment strategy. Realised and unrealised gains and losses arising from changes in fair value are included in profit or loss in the period in which they arise.

(ii) Loans and receivables

Loans and receivables are non-derivative financial assets with fixed or determinable payments that are not quoted in an active market and are subsequently measured at amortised cost using the effective interest rate method.

(iii) Held-to-maturity investments

Held-to-maturity investments are non-derivative financial assets that have fixed maturities and fixed or determinable payments, and it is the company's intention to hold these investments to maturity. They are subsequently measured at amortised cost using the effective interest rate method.

(iv) Available-for-sale financial assets

Available-for-sale financial assets are non-derivative financial assets that are either designated as such or that are not classified in any of the other categories. They comprise investments in the equity of other entities where there is neither a fixed maturity nor fixed or determinable payments.

(v) Financial liabilities

Non-derivative financial liabilities (excluding financial guarantees) are subsequently measured at amortised cost using the effective interest rate method.

Fair value

Fair value is determined based on current bid prices for all quoted investments. Valuation techniques are applied to determine the fair value for all unlisted securities, including recent arm's length transactions, reference to similar instruments and option pricing models.

c. Financial Instruments (cont'd)

Impairment

At each reporting date, the entity assesses whether there is objective evidence that a financial instrument has been impaired. In the case of available-for-sale financial instruments, a prolonged decline in the value of the instrument is considered to determine whether impairment has arisen. Impairment losses are recognised in the Income Statement.

d. Impairment of Assets

At each reporting date, the entity reviews the carrying values of its tangible and intangible assets to determine whether there is any indication that those assets have been impaired. If such an indication exists, the recoverable amount of the asset, being the higher of the asset's fair value less cost to sell and value in use, is compared to the asset's carrying value. Any excess of the asset's carrying value over its recoverable amount is expensed to the Income Statement.

Where the future economic benefits of the asset are not primarily dependent upon on the assets ability to generate net cash inflows and when the entity would, if deprived of the asset, replace its remaining future economic benefits, value in use is depreciated replacement cost of an asset.

Where it is not possible to estimate the recoverable amount of a class of asset, the entity estimates the recoverable amount of the cash-generating unit to which the asset belongs.

e. Employee Benefits

Provision is made for the entity's liability for employee benefits arising from services rendered by employees to Balance Sheet date. Employee benefits expected to be settled within one year together with benefits arising from wages, salaries and annual leave, which may be settled after one year, have been measured at the amounts expected to be paid when the liability is settled plus related on costs. Other employee benefits payable later than one year have been measured at the net present value.

Contributions are made by the entity to an employee superannuation fund and are charged as expenses when incurred.

f. Cash and cash equivalents

Cash and cash equivalents include cash on hand, deposits held at-call with banks, other short-term highly liquid investments with original maturities of three months or less, and bank overdrafts.

g. Goods and Services Tax (GST)

Revenues, expenses and assets are recognised net of the amount of GST, except where the amount of GST incurred is not recoverable from the Australian Taxation Office. In these circumstances the GST is recognised as part of the cost of acquisition of the asset or as part of an item of expense. Receivables and payables in the Balance Sheet are shown inclusive of GST.

Cash flows are presented in the Cash Flow Statement on a gross basis, except for the GST component of investing and financing activities, which are disclosed as operating cash flows.

h. Income Tax Expenses

No provision for income tax has been raised, as the entity is exempt from income tax under Division 50 of the Income Tax Assessment Act 1997.

i. Provisions

Provisions are recognised when the entity has a legal or constructive obligation, as a result of past events, for which it is probable that an outflow of economic benefits will result and that outflow can be reliably measured.

j. Comparative Figures

Where required by Accounting Standards comparative figures have been adjusted to conform with changes in presentation for the current financial year.

k. Critical Accounting Estimates and Judgments

The directors evaluate estimates and judgments incorporated into the financial report based on historical knowledge and best available current information. Estimates assume a reasonable expectation of future events and are based on current trends and economic data, obtained both externally and within the entity.


